RULES AND REGULATIONS

- 1. Models to be flown must be airworthy. If in doubt, seek assistance from the club executive committee members or flight instructors.
- 2. Pilots who have not passed their basic proficiency test are <u>not</u> allowed to fly without supervision by a club flight instructor.
- 3. Model engines must only be started in the pits area (outside the tent), ensure the exhaust is not directed at another fellow! Helicopters must be started outside the tent on the helicopter patch.
- 4. Landings have priority over take offs. All take offs should be on the runways.
- 5. Flying over the tents, pits or car park is forbidden, for obvious reasons.
- 6. Young children and dogs must be restrained to avoid the possibility of falling or walking into models or spinning propellers.
- 7. Do help to keep our site litter free. Make use of trash bags provided to collect and take away your broken planes. Do not leave these on the site. Make use of trash bins provided for small items only.
- 8. Smile and enjoy yourself.
